First Contact - Camping in No Camping Area - With Land Use Permit	Citation - \$150.00 per day, per person fine. If not compliant within 30 days of citation issued date, and evidence submitted to AST as a criminal trespass complaint, and a \$1,000.00 late fee added.

Second Contact - No Land Use Permit or ID on person while accessing Lands	Citation - \$150.00 and person must submit proof of Land Use Permit that was purchased before issued citation date in 10 days, if not compliant in 10 Days of citation issued date, another citation will be issued for No Land Use Permit (\$250.00) + \$1000.00 fine , and evidence submitted to AST as a criminal trespass complaint.
First Contact - Failure to present permit to Land Security Officer's upon request	Citation - \$500.00 Fine + Evidence Submitted to AST as a criminal trespass complaint.
